The Door's Legal Services Center was established in 1992 to address the lack of free legal assistance for youth in New York City. The Center provides a broad range of counsel and advocacy services in civil matters and is widely regarded as a leader in protecting the rights of youth in foster care and in immigration and family law issues. In addition to providing legal counsel and representation, the Legal Services Center conducts legal education workshops and is called upon to inform public policy discussions. The Center is an invaluable resource for both the young people it serves as well as other community-based organizations working on youth-related issues.

Founded in 1972, The Door ([www.door.org](http://www.door.org)) provides a full range of integrated services at a single site, free of charge to any adolescent between the ages of 12 and 21. With special areas of expertise in helping older youth who have failed in school and the City's younger at-risk youth, The Door's services include health care, education and career development, a broad range of arts programming, food and nutrition, legal assistance, and counseling. The Door served approximately 9,000 low-income youth from all five boroughs during the last year alone.
